# 1 Opening Remarks from the Chair

# 4 ALIEX Advisory Board report and appointments

A report from the ALIEX Executive Committee was circulated with the meeting materials. The report was comprised of two parts: a recommendation to the Benchers for director appointments from the Executive Committee, which acts as the Nominating Committee for ALIEX, and a report to the Benchers on recent ALIEX and ALIA activities.

The Advisory Board Chair presented the recommendation for appointments to the Advisory Board, highlighting the background, succession planning process followed, and proposed appointments, noting that the Benchers have the exclusive power to appoint the Advisory Board. The Advisory Board Chair advised the Benchers that approval of the recommendation will continue the staggering of terms of appointment and improve gender balance, geographical representation and the balance of internal and independent directors. The Advisory Board Chair confirmed that there are no material financial ramifications resulting from the recommendation.

Resolved as a resolution of the Benchers of the Law Society of Alberta:

- 1. The number of Alberta Lawyers Insurance Exchange ("ALIEX") Advisory Board members remain at 10.
- 2. The resignation of Nancy Dilts from the ALIEX Advisory Board effective May 4, 2018 is accepted.
- 3. Carsten Jensen will complete his term effective June 9, 2018 and is not being reappointed.
- 4. The following persons are appointed to the ALIEX Advisory Board effective June 10, 2018 for a term expiring on the date of the first Bencher meeting after May 31, 2021, or their sooner resignation or removal from office:

Sheri Epp; Zoe Harrison; and Dale Spackman.

5. This resolution shall be effective only if passed by the affirmative votes of at least 2/3 of the Benchers so voting and the Benchers so voting constitute a majority of the Benchers.
