### **Notice of Disbarment**

On June 25, 2013, a Resignation Committee of the Benchers of the Law Society of Alberta granted the application of **Victor Anthony Samy** to resign, pursuant to section 61 of the *Legal Profession Act*, R.S.A. 2000, c. L-8, and Rule 92 of the *Rules of the Law Society of Alberta*, effective immediately. Mr. Anthony Samy is therefore disbarred.

Mr. Anthony Samy was a suspended member of the Law Society of Alberta. His last known address is Toronto, Ontario and he practised in Edmonton, Alberta from August 8, 1979 to August 9, 1996.

Mr. Anthony Samy faced a discipline hearing on five citations: failing to be candid in his responses to The Law Society of Alberta and its representatives; failing to cooperate with The Law Society of Alberta in the investigation of complaints; conducting himself in a manner which brings the profession into disrepute, in relation but not specifically restricted to the potential theft or misappropriation of funds received from A.S. and the potential counseling of an offence under the *Immigration Act*; failing to keep proper accounting records and failing to provide A.S. with an accounting of funds received; and practicing while under suspension of The Law Society of Alberta.

Mr. Anthony Samy has admitted facts to support the citation regarding practicing under suspension. The Statement of Facts containing this admission has been attached to Mr. Anthony Samy's roll. A copy of it may be obtained from the Law Society upon request.

Mr. Anthony Samy previously transferred all of his open files to Thomas Edward Spratlin.

The Resignation Committee directed that Mr. Anthonysamy pay the costs of the discipline proceedings and the resignation application, in the amount of \$1,395.75, prior to any application for re-admission.
