# Application by an Out-of-Province Lawyer for Enrolment under Section 41

## **Instructions to the Applicant**

## 1. General Information for the applicant

In preparing your application, you should refer to section 41 of the *Legal Profession Act* (R.S.A. 2000, c. L-8), the Law Society of Alberta Code of Conduct and to Part 2 of the Rules of the Society, in particular Rule 50, 66 and 70 to 73. The relevant provisions are set out in the material respecting applications for enrolment and available on request from the Society.

The personal information collected in this form will be used by the Law Society for one or more purposes contemplated by the *Legal Profession Act*, the Rules of the Law Society, the Code of Conduct, or a resolution of the Benchers and will be accessible to all departments of the Law Society, including the Alberta Lawyers Insurance Association. The information may be used or disclosed by the Law Society, now or in the future, for regulatory purposes, including Law Society investigations and proceedings. We may contact you to obtain additional information, or to obtain clarification on the information you provided. Should you have any questions about the collection, use or disclosure of this information, please contact please contact the Privacy Officer at (403) 229-4700.

2. Documents and fees to accompany your application

Your application must be accompanied by the following:

- (a) a certificate of standing from each of the extraprovincial law societies within or outside of Canada of which you are, or have been, a member, each in compliance with section 4 of these instructions;
- (b) unless waived in whole or in part by the Executive Director, a statement from each of your current errors and omissions insurers and a statement from each of your previous errors and omissions insurers, setting out the claims made against you, claims paid on your behalf, the nature of each claim and the cost to the insurer of each claim;
- (c) payment of the prescribed application fee;
- (d) payment of the prescribed enrolment fee;
- (e) on becoming enrolled as a member, the professional liability insurance assessment for the current year or proof that you will, on becoming a member, be exempt from the requirement to pay that assessment;
- (f) full particulars in regard to any affirmative statement made in sections 9 to 25 of the application.

Payment of the professional liability insurance is not required if you accompany your application with an election to become an inactive member (Form 2-20) of the Society on becoming enrolled.

As to exemptions from the payment of the professional liability insurance assessment, see Rule 148.

#### 3. Definition

For the purpose of Form 2-15:

"extraprovincial law society" means

- (a) in relation to Canada, a law society or comparable governing body of the legal profession or a class of the legal profession of a province or territory of Canada other than Alberta, or
- (b) in relation to a country outside Canada or a political subdivision of a country outside Canada, the body or official governing or regulating the legal profession or a class of the legal profession within that country or political subdivision.

## 4. Certificate from extraprovincial law society

Each certificate from an extraprovincial law society of which you are or have been a member must be dated within the 30-day period prior to the furnishing of all documents and fees required to be submitted by you. Each certificate must show the following as at the date of the certificate and to the extent that the society's records contain the relevant information:

- that you are a member of that society and whether or not you are in good standing as a member of that society;
- (b) the period or periods during which you have been lawfully entitled to actively engage in the practice of law in the other province or territory in the 5-year period preceding the date of the certificate;
- (c) whether any disciplinary or competency proceedings are pending against you before that society and, if so, the nature of the conduct that is the subject of the proceedings;
- (d) the nature of any orders made or measures taken against you as a result of disciplinary or competency proceedings taken against you by the society and the nature of the conduct that was the subject of the proceedings;
- (e) particulars respecting any compensation paid by that society for loss resulting from misappropriation or wrongful conversion of property received by you in your capacity as a lawyer in that society's jurisdiction, and whether any claims are pending before that society for compensation of that kind arising out of your conduct;
- (f) whether you are, or have at any prior time been, the subject of an order in that province or territory under which all or part of the property owned or held by you in connection with your practice as a lawyer is placed in the custody of a court, the society or a custodian or trustee and, if so, particulars relating to the order;
- (g) whether your right to practise law in the other province or territory is confined to a specified field or fields of law or is otherwise subject to any restrictions or conditions, either voluntarily or by the imposition of any order by that society, and if so, particulars relating to the restrictions or conditions.
